



JOHNSON COUNTY QUALITY OF LIFE GRANTS

Fiscal Year 2023 Grant Application

Each year through the budgeting processes, the Johnson County Board of Supervisors allocates funds to promote economic development in Johnson County and enhance the quality of life of its residents. The grants are taxpayer-funded and the Board of Supervisors determines the process, allocation, and oversight of the funds.

The Johnson County Board of Supervisors is accepting applications for Johnson County’s Economic Development and Quality of Life Grants. The application process for Fiscal Year 2023 opens Friday, October 1, 2021 and closes Monday, November 15, 2021. Applicants will receive notification of the Board’s decisions after the final budget is approved and published in March 2022. Funds approved to be distributed to grant recipients in the Fiscal Year 2023 budget will be paid in biannual or quarterly payments between July 1, 2022 and June 30, 2023.

Grant recipients are required to submit two reports on the impact of the grant funds, a mid-year report by January 31, 2022 and an end-of-year report by July 31, 2023 of their award year. Failure to submit required reports may affect eligibility in subsequent years.

Applicant Eligibility

Economic Development and Quality of Life Grants will be made only to organizations located in Johnson County, Iowa or with a branch location in Johnson County, and whose work directly benefits Johnson County residents. An organization can only apply to one grant program--either an Economic Development or a Quality of Life grant.

Project Eligibility

Economic Development Grants

Grant funds may be used only for programs or projects that directly benefit Johnson County residents. Priority is given to requests for programmatic and capital projects that provide public service over requests for operating support. Grant funds may be used only for expenses that have not yet been incurred. Projects are funded for one-year increments.

Preferred applications will be for projects/programs that accomplish the following:

- A. Maintain a fiscally responsible County budget;
- B. Support County economic development goals as identified in the Land Use Plan and/or promote rural economic development in particular;
- C. Create and encourage public/private partnerships;
- D. Increase and diversify the County tax base;
- E. Maintain or improve the County's standard of living;
- F. Improve workforce opportunities for Johnson County residents.

Quality of Life Grants

Grant funds may be used only for programs or projects that directly benefit Johnson County residents. Priority is given to requests for programmatic and capital projects that provide public service over requests for operating support. Grant funds may be used only for expenses that have not yet been incurred. Projects are funded for one-year increments.

Preferred applications will be for projects/programs that accomplish the following:

- A. Maintain a fiscally responsible County budget;
- B. Improve the quality of life for County residents;
- C. Create a more livable community;
- D. Create and encourage public/private partnerships.

Grantee Requirements

- A. Grant funding must be used for the project described in Applicant's approved application. If Applicant finds the need to use the funding for other purposes, Applicant must request permission from the Board of Supervisors in writing prior to doing so. - B. The Board of Supervisors may request, at any time, that a representative from Applicant's organization attend a public meeting to report on the progress toward the completion of the Applicant's project.

- C. Media releases, annual reports, and materials printed with grant funds should credit the Johnson County Board of Supervisors Economic Development or Quality of Life Grant Program.

- D. A final report is required, and the form is included on our webpage. Documentation of grant expenses is required and can include copies of receipts or copies of paid invoices. Final reports are due July 31, 2023. Organizations that fail to meet this requirement will be ineligible for future Economic and Community Development grants without specific Board of Supervisors approval.

Evaluation Criteria

Applications will be evaluated on the criteria listed below:

- A. Project design and innovation
 - a. Clearly outlined plan, including timeline and achievable goals;
 - b. Activities are well-defined and link to project goals;
 - c. Proposal addresses how the project relates to the Board's current priorities.
- B. Knowledge of community need
 - a. Need is well-researched and at the center of the project;
 - b. Activities engage and empower those it serves;
 - c. Project creates innovative solutions to addressed need.
- C. Impact and outcomes of proposed programming
 - a. Programming addresses both long and short term impacts;
 - b. Proposal includes a variety of methods to evaluate the project.
- D. Sustainability efforts
 - a. Proof of staff expertise or experience to support the proposed project;
 - b. Project can be replicated to benefit additional communities;
 - c. Evidence of forward planning for the project, if reoccurring.
- E. Financial information
 - a. The proposed budget is accurate, cost effective, and linked to activities and outcomes;
 - b. The application details how the proposed activity will be funded in the future.

Selection Process

The Johnson County Board of Supervisors Economic Development and Quality of Life Fund receives more funding requests than can be approved. If an application for a worthwhile program is not approved, the decision does not reflect on the value of the group or service, but rather on the need to be selective because of limited resources.
